 - ii. Current admission numbers are up for spring 2022. Many already admitted could be due to fall 2021 deferrals.
 - iii. New Computer Science degree program is attracting international student interest.

New Business

- a. Make-up of Graduate Council Membership Discussion
 - i. An Associate Dean applied for a seat on the Research Committee in the spring and won. Noelle asked the administrator to hold off accepting until Council had a chance to discuss the make-up of committees. No recollection of administrators occupying a seat on Council in the past and no information exists in the Bylaws. Members of the Council commenced discussion. Points from discussion follow:
 - Administrators should not be taking faculty spots when administrators are already making decisions.
 - Need to take into consideration additional units/centers on campus with same type of faculty configuration as Milner?
 - Faculty members work on a day-to-day basis with graduate students.
 - The faculty are a check on the administration's decisions.
 - Faculty need to be involved when it comes to changing policies that apply to graduate education.
 - Provost White Paper should be considered if changes are made to Bylaws.
 - ii. Any approved changes made to Bylaws this year will not go into effect until next academic year.
- b. Other Discussion
 - Graduate faculty status as it applies to NTT faculty. Should they be allowed to apply for graduate faculty status again?
 - When the graduate assistant union ratifies a contract, how will it play into the Provost White Paper recommendations?
 - How are assigned tasks from White Paper being implemented?
 - Graduate studies play into so many areas of the University.
 - Pandemic highlighted needs and recommendations for graduate students.
